# EQUIVALENT REGULAR PARTITIONS OF 3-UNIFORM HYPERGRAPHS 

BRENDAN NAGLE, VOJTĚCH RÖDL, AND MATHIAS SCHACHT


#### Abstract

The regularity method was pioneered by Szemerédi for graphs and is an important tool in extremal combinatorics. Over the last two decades, several extensions to hypergraphs were developed which were based on seemingly different notions of quasirandom hypergraphs. We consider the regularity lemmata for 3-uniform hypergraphs of Frankl and Rödl and of Gowers, and present a new proof that the concepts behind these approaches are equivalent.


## §1. Introduction

Szemerédi [13] introduced the regularity method for graphs, which became an important tool in extremal graph theory. The regularity lemma asserts that every large graph $G=(V, E)$ can be approximated by a bounded number of quasirandom bipartite subgraphs that are induced by a partition of $V$. This approximation allows the use of results on quasirandom graphs for the analysis of $G$, which is a key feature in the success of the regularity method.

Szemerédi's regularity lemma was extended from graphs to $k$-uniform hypergraphs by Rödl et al. [3, 9, 12] and Gowers [4, 5]. For a fixed $k$-uniform hypergraph $H=(V, E)$, these regularity lemmata provide well-structured partitions $\mathcal{P}$ of $V^{(k-1)}=\{X \subseteq V:|X|=k-1\}$ where for most edges $e \in E$, the hypergraph $H$ is quasirandom on the unique minimal family of classes from $\mathcal{P}$ containing a $(k-1)$-element subset from $e$. By quasirandom, we follow either uniform edge distribution $[3,9,12]$ or deviation $[4,5]$.

For graphs it is well known that both concepts are essentially equivalent quasirandom properties and for 3 -uniform hypergraphs a similar equivalence was obtained in joint work with Poerschke [7]. The proof from [7] is technical and it invokes two applications of the hypergraph regularity lemma. Here, we present a conceptually simpler proof using a single application of the regularity lemma.

[^0]1.1. Quasirandom bipartite graphs. We begin our discussion with the notion of quasirandomness that is central to Szemerédi's regularity lemma. For $\varepsilon>0$ and $d \in[0,1]$, we say a bipartite graph $G=(X \cup Y, E)$ is $(\varepsilon, d)$-regular if all subsets $X^{\prime} \subseteq X$ and $Y^{\prime} \subseteq Y$ satisfy
\[

\left|e\left(X^{\prime}, Y^{\prime}\right)-d\right| X^{\prime}| | Y^{\prime}| | \leqslant \varepsilon|X||Y| \tag{1}
\end{equation*}

\]

where $e\left(X^{\prime}, Y^{\prime}\right)$ denotes the number of edges between $X^{\prime}$ and $Y^{\prime}$. Note that (1) ensures a fairly uniform edge density across the large induced bipartite subgraphs of $G$, which is a property holding almost surely in the binomial random bipartite graph.

The second notion of quasirandomness considers induced subgraphs on only four vertices. For $\delta>0$ and $d \in[0,1]$, we say $G=(X \cup Y, E)$ is $(\delta, d)$-conformant* if

\sum_{x_{0}, x_{1} \in X} \sum_{y_{0}, y_{1} \in Y} \prod_{\lambda, \mu \in\{0,1\}} f_{G, d}\left(x_{\lambda}, y_{\mu}\right) \leqslant \delta|X|^{2}|Y|^{2}
$$

where $f_{G, d}: X \times Y \longrightarrow[-1,1]$ is the $d$-shifted indicator of $E$ given by

$$
f_{G, d}(x, y)=\mathbb{1}_{E}(x, y)-d
$$

Note that when $d=d(X, Y)$ is the density of $G$ above, $f_{G, d}$ sums to 0 over $X \times Y$.
The aforementioned equivalence is made precise by the following two statements:
(i) For all $d \in[0,1]$ and $\varepsilon>0$, there exists $\delta>0$ such that every $(\delta, d)$-conformant bipartite graph is $(\varepsilon, d)$-regular.
(ii) For all $d \in[0,1]$ and $\delta>0$, there exists $\varepsilon>0$ such that every sufficiently large $(\varepsilon, d)$-regular bipartite graph is $(\delta, d)$-conformant.

We briefly sketch the well known proofs of $(i)$ and (ii).
The proof of the implication in $(i)$ starts with the identity

e\left(X^{\prime}, Y^{\prime}\right)-d\left|X^{\prime}\right|\left|Y^{\prime}\right|=\sum_{x \in X^{\prime}} \sum_{y \in Y^{\prime}} f_{G, d}(x, y)=\sum_{x \in X} \sum_{y \in Y} \mathbb{1}_{X^{\prime}}(x) \mathbb{1}_{Y^{\prime}}(y) f_{G, d}(x, y) .
$$

With two applications of the Cauchy-Schwarz inequality, to separate the indicator functions involving vertices from $X$ and from $Y$, one can show that

$$
\left|e\left(X^{\prime}, Y^{\prime}\right)-d\right| X^{\prime}| | Y^{\prime}| |^{4} \leqslant\left|X^{\prime}\right|^{2} \cdot\left|Y^{\prime}\right|^{2} \cdot \sum_{x_{0}, x_{1} \in X} \sum_{y_{0}, y_{1} \in Y} \prod_{\lambda, \mu \in\{0,1\}} f_{G, d}\left(x_{\lambda}, y_{\mu}\right)
$$

and the $(\varepsilon, d)$-regularity follows from the assumed $(\delta, d)$-conformity when $\delta \leqslant \varepsilon^{4}$.
The proof of implication (ii) makes use of the following bounds (see (2) below) on the number of induced copies of subgraphs of the 4 -cycle $C_{4}=K_{2,2}$. Let $F$ be a spanning subgraph

[^1]of $K_{2,2}$ with vertex partition $\left\{x_{0}, x_{1}\right\} \cup\left\{y_{0}, y_{1}\right\}$. We say a function $\varphi: V(F) \longrightarrow V(G)$ is an induced homomorphism when $x y \in E(F)$ if, and only if, $\varphi(x) \varphi(y) \in E(G)$. If in addition, $\varphi$ satisfies $\varphi\left(x_{0}\right), \varphi\left(x_{1}\right) \in X$ and $\varphi\left(y_{0}\right), \varphi\left(y_{1}\right) \in Y$, then $\varphi$ is a partite induced homomorphism of $F$ into $G$, and we denote the number of such homomorphisms by ihom $(F, G)$.

If $G=\left(X \cup Y, E_{G}\right)$ is an $(\varepsilon, d)$-regular bipartite graph, then the counting lemma for graphs implies

$$
\begin{equation*}
\left.\left.\left|\operatorname{ihom}(F, G)-d^{|E(F)|}(1-d)^{4-|E(F)|}\right| X\right|^{2}|Y|^{2}|\leqslant 4 \varepsilon| X\right|^{2}|Y|^{2} . \tag{2}
\end{equation*}
$$

The proof of (ii) then follows immediately for $\varepsilon \leqslant \delta / 64$ from the identity

$$
\sum_{x_{0}, x_{1} \in X} \sum_{y_{0}, y_{1} \in Y} \prod_{\lambda, \mu \in\{0,1\}} f_{G, d}\left(x_{\lambda}, y_{\mu}\right)=\sum_{F \subseteq C_{4}}(1-d)^{|E(F)|}(-d)^{4-|E(F)|} \text { ihom }(F, G) .
$$

with 16 applications of (2), one for every labeled spanning subgraph $F \subseteq K_{2,2}$.
1.2. Quasirandom tripartite hypergraphs. We continue the discussion above for 3uniform hypergraphs. In the context of the 3 -uniform hypergraph regularity lemma, we consider 3-partite 3-uniform hypergraphs $H=\left(V, E_{H}\right)$, where $E_{H}$ is a subset of the triangles of an underlying graph $G=\left(V, E_{G}\right)$ on the same vertex set $V$. To make this precise, we denote by $\mathcal{K}_{3}(G)$ the set of triples of vertices, which span a graph triangle $K_{3}$ in $G$. We say that $G=\left(V, E_{G}\right)$ underlies $H=\left(V, E_{H}\right)$ when $E_{H} \subseteq \mathcal{K}_{3}(G)$. Also, for a subgraph $J \subseteq G$, we write $E_{H}(J)=E_{H} \cap \mathcal{K}_{3}(J)$ for the set of hyperedges matching triangles of $J$, and we set

$$
e_{H}(J)=\left|E_{H} \cap \mathcal{K}_{3}(J)\right|
$$

The following notion of a complex plays a similar rôle in the hypergraph regularity lemma as a bipartite graph does in the graph regularity lemma.

Definition 1.1 (complex). For $\varepsilon_{2}, d_{2}>0$, an $\left(\varepsilon_{2}, d_{2}\right)$-complex $\mathcal{H}=((X, Y, Z), G, H)$ is a triple satisfying the following properties:
(a) $X, Y$, and $Z$ are pairwise disjoint vertex sets with $|X|=|Y|=|Z|$;
(b) $G=\left(X \cup Y \cup Z, E_{G}\right)$ is a 3-partite graph where each of the induced bipartite subgraphs $G[X, Y], G[X, Z]$, and $G[Y, Z]$ is $\left(\varepsilon_{2}, d_{2}\right)$-regular;
(c) $H=\left(X \cup Y \cup Z, E_{H}\right)$ is a 3-uniform hypergraph which $G$ underlies, i.e., $E_{H} \subseteq \mathcal{K}_{3}(G)$. More simply, we refer to $G$ as a triad and $\mathcal{H}$ as a complex.

We now introduce analogues of regularity and conformity for complexes.

Definition 1.2 (regular complex). Let $\mathcal{H}=((X, Y, Z), G, H)$ be an $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n$ vertices. For $\varepsilon_{3}>0$ and $d_{3} \in[0,1]$, we say $\mathcal{H}$ is $\left(\varepsilon_{3}, d_{3}\right)$-regular if all subgraphs $J \subseteq G$ satisfy

$$
\left|e_{H}(J)-d_{3}\right| \mathcal{K}_{3}(J)| | \leqslant \varepsilon_{3} \cdot d_{2}^{3} n^{3} .
$$

In Definition 1.2, the quantity $d_{2}^{3} n^{3}$ approximates the number of triangles of $G$ (cf. (b) of Definition 1.1). Similarly, the quantity $d_{2}^{12} n^{6}$ below approximates its number of $K_{2,2,2}$ 's.

Definition 1.3 (conformant complex). Let $\mathcal{H}=((X, Y, Z), G, H)$ be an $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n$ vertices. For $\delta_{3}>0$ and $d_{3} \in[0,1]$, we say $\mathcal{H}$ is $\left(\delta_{3}, d_{3}\right)$-conformant if

$$
\sum_{x_{0}, x_{1} \in X} \sum_{y_{0}, y_{1} \in Y} \sum_{z_{0}, z_{1} \in Z} \prod_{\lambda, \mu, \nu \in\{0,1\}} f_{\mathcal{H}, d_{3}}\left(x_{\lambda}, y_{\mu}, z_{\nu}\right) \leqslant \delta_{3} \cdot d_{2}^{12} n^{6},
$$

where $f_{\mathcal{H}, d_{3}}: X \times Y \times Z \longrightarrow[-1,1]$ is defined by

$$
\begin{equation*}
f_{\mathcal{H}, d_{3}}(x, y, z)=\mathbb{1}_{\mathcal{K}_{3}(G)}(x, y, z) \cdot\left(\mathbb{1}_{E_{H}}(x, y, z)-d_{3}\right) . \tag{3}
\end{equation*}
$$

Note that when $d_{3}$ is the relative density of $H$

$$
d(H \mid G)= \begin{cases}\frac{e_{H}(G)}{\left|\mathcal{K}_{3}(G)\right|}, & \text { if } \mathcal{K}_{3}(G) \neq \varnothing \\ 0, & \text { otherwise }\end{cases}
$$

the $f_{\mathcal{H}, d_{3}}$ sums to 0 over $X \times Y \times Z$.
It was proven in [7] that Definitions 1.2 and 1.3 are equivalent. We will give an alternative proof of this equivalence. First, we will show that conformity implies regularity.

Proposition 1.4. For all $\delta_{3}, d_{3}, d_{2}>0$, there exists $\varepsilon_{2}>0$ so that the following holds. If $\mathcal{H}$ is a $\left(\delta_{3}, d_{3}\right)$-conformant $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n$ vertices, then $\mathcal{H}$ is $\left(\left(2 \delta_{3}\right)^{1 / 8}, d_{3}\right)$-regular.

Proposition 1.4 follows from standard iterative applications of the Cauchy-Schwarz inequality (similar to those in the proof of $(i)$ in Section 1.1).

Second, we will show that regularity implies conformity.
Theorem 1.5. For all $\delta_{3}, d_{3}>0$, there exists $\varepsilon_{3}>0$ so that for every $d_{2}>0$, there exist $\varepsilon_{2}>0$ and $n_{0} \in \mathbb{N}$ so that the following holds. If $\mathcal{H}$ is an $\left(\varepsilon_{3}, d_{3}\right)$-regular $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n \geqslant 3 n_{0}$ vertices, then $\mathcal{H}$ is $\left(\delta_{3}, d_{3}\right)$-conformant.

The new proof of Theorem 1.5 is the main contribution here. The main challenge is that its quantification allows for $d_{2} \ll \varepsilon_{3}, \delta_{3}$, whereby the underlying graph $G$ is much sparser than the hypergraph $H$ is regular. This quantification matches the environment obtained by the hypergraph regularity lemma and cannot be avoided. To overcome this challenge, in [7] two
applications of the regularity lemma for hypergraphs were used. We present a simpler proof using one such application. In the opposite extreme $d_{2} \gg \varepsilon_{3}, \delta_{3}$, the corresponding version of Theorem 1.5 appears in $[1,6]$.

Organisation. In Section 2, we prove Proposition 1.4. The proof of Theorem 1.5 is based on estimates similar to (2), where in a regular 3 -uniform complex we estimate the number of induced copies of all 3-partite subhypergraphs on vertex classes of size two. Theorem 3.1 of Section 3 provides these bounds, and we deduce Theorem 1.5 in that section. In Section 5, we prove Theorem 3.1. This proof is based on the regularity method for 3-uniform hypergraphs, which we review in Section 4.

## §2. Proof of Proposition 1.4: Conformity implies Regularity

The proof of Proposition 1.4 is based on three applications of the Cauchy-Schwarz inequality, and follows lines similar to the proof of $(i)$ in Section 1.1. Let $\mathcal{H}=((X, Y, Z), G, H)$ be a $\left(\delta_{3}, d_{3}\right)$-conformant $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n$ vertices, where $\varepsilon_{2}=\varepsilon_{2}\left(d_{2}\right)>0$ satisfies

$$
\begin{equation*}
\left(d_{2}+\varepsilon_{2}\right)^{4} \cdot\left(d_{2}^{2}+2 \varepsilon_{2}\right)^{2} \cdot\left(d_{2}^{4}+4 \varepsilon_{2}\right) \leqslant 2 d_{2}^{12} . \tag{4}
\end{equation*}
$$

Fix a subgraph $J \subseteq G$. Since $f_{\mathcal{H}, d_{3}}(x, y, z)$ in (3) is $\mathbb{1}_{E(H)}(x, y, z)-d_{3}$ on $x y z \in \mathcal{K}_{3}(J)^{\dagger}$, the quantity $e_{H}(J)-d_{3}\left|\mathcal{K}_{3}(J)\right|$ equals

$$
\sum_{x y z \in \mathcal{K}_{3}(J)} f_{\mathcal{H}, d_{3}}(x, y, z)=\sum_{x \in X} \sum_{y \in Y} \mathbb{1}_{E_{J}}(x, y) \sum_{z \in Z} \mathbb{1}_{E_{J}}(x, z) \mathbb{1}_{E_{J}}(y, z) f_{\mathcal{H}, d_{3}}(x, y, z)
$$

A first application of the Cauchy-Schwarz inequality yields

$$
\begin{aligned}
\left.\left|e_{H}(J)-d_{3}\right| \mathcal{K}_{3}(J)\right|^{2} & \leqslant \sum_{x \in X} \sum_{y \in Y} \mathbb{1}_{E_{J}}^{2}(x, y) \cdot \sum_{x \in X} \sum_{y \in Y}\left(\sum_{z \in Z} \mathbb{1}_{E_{J}}(x, z) \mathbb{1}_{E_{J}}(y, z) f_{\mathcal{H}, d_{3}}(x, y, z)\right)^{2} \\
& =e_{J}(X, Y) \sum_{z_{0}, z_{1} \in Z} \sum_{x \in X} \prod_{\nu \in\{0,1\}} \mathbb{1}_{E_{J}}\left(x, z_{\nu}\right) \sum_{y \in Y} \prod_{\nu \in\{0,1\}} \mathbb{1}_{E_{J}}\left(y, z_{\nu}\right) f_{\mathcal{H}, d_{3}}\left(x, y, z_{\nu}\right) .
\end{aligned}
$$

[^2]A second application of the Cauchy-Schwarz inequality bounds $\left|e_{H}(J)-d_{3}\right| \mathcal{K}_{3}(J)| |^{4}$ by

$$
\begin{aligned}
& e_{J}(X, Y)^{2} \cdot \sum_{z_{0}, z_{1} \in Z} \sum_{x \in X}\left(\prod_{\nu \in\{0,1\}}\right. \\
&\left.\mathbb{1}_{E_{J}}\left(x, z_{\nu}\right)\right)^{2} \cdot \sum_{z_{0}, z_{1} \in Z} \sum_{x \in X}\left(\sum_{y \in Y} \prod_{\nu \in\{0,1\}} \mathbb{1}_{E_{J}}\left(y, z_{\nu}\right) f_{\mathcal{H}, d_{3}}\left(x, y, z_{\nu}\right)\right)^{2} \\
& \leqslant e_{J}(X, Y)^{2} \cdot \operatorname{hom}\left(K_{1,2}, J[X, Z]\right) \\
& \cdot \sum_{y_{0}, y_{1} \in Y} \sum_{z_{0}, z_{1} \in Z} \prod_{\mu, \nu \in\{0,1\}} \mathbb{1}_{E_{J}}\left(y_{\mu}, z_{\nu}\right) \sum_{x \in X} \prod_{\mu, \nu \in\{0,1\}} f_{\mathcal{H}, d_{3}}\left(x, y_{\mu}, z_{\nu}\right),
\end{aligned}
$$

where hom $\left(K_{1,2}, J[X, Z]\right)$ denotes the number of (partite) graph homomorphisms of $K_{1,2}$ into $J[X, Z]$. A third application of the Cauchy-Schwarz inequality yields

$$
\begin{align*}
\left|e_{H}(J)-d_{3}\right| \mathcal{K}_{3}(J)| |^{8} \leqslant e_{J}(X, Y)^{4} \cdot & \operatorname{hom}\left(K_{1,2}, J[X, Z]\right)^{2} \cdot \operatorname{hom}\left(K_{2,2}, J[Y, Z]\right) \\
& \cdot \sum_{x_{0}, x_{1} \in X} \sum_{y_{0}, y_{1} \in Y} \sum_{z_{0}, z_{1} \in Z} \prod_{\lambda, \mu, \nu \in\{0,1\}} f_{\mathcal{H}}\left(x_{\lambda}, y_{\mu}, z_{\nu}\right), \tag{5}
\end{align*}
$$

where $\operatorname{hom}\left(K_{2,2}, J[Y, Z]\right)$ is defined analogously to $\operatorname{hom}\left(K_{1,2}, J[X, Z]\right)$. Now, the $\left(\varepsilon, d_{2}\right)$ regularity of $G[X, Y], G[X, Z]$, and $G[Y, Z]$ guarantees (see, e.g., (2))

$$
\begin{aligned}
e_{J}(X, Y) & \leqslant e_{G}(X, Y) \leqslant\left(d_{2}+\varepsilon_{2}\right) n^{2}, \\
\operatorname{hom}\left(K_{1,2}, J[X, Z]\right) & \leqslant \operatorname{hom}\left(K_{1,2}, G[X, Z]\right) \leqslant\left(d_{2}^{2}+2 \varepsilon_{2}\right) n^{3}, \\
\text { and } \quad \operatorname{hom}\left(K_{2,2}, J[Y, Z]\right) & \leqslant \operatorname{hom}\left(K_{2,2}, G[Y, Z]\right) \leqslant\left(d_{2}^{4}+4 \varepsilon_{2}\right) n^{4} .
\end{aligned}
$$

Applying these bounds and the $\left(\delta_{3}, d_{3}\right)$-conformity of $\mathcal{H}$ to (5) implies

$$
\left.\left|e_{H}(J)-d_{3}\right| \mathcal{K}_{3}(J)\right|^{8} \leqslant\left(d_{2}+\varepsilon_{2}\right)^{4} n^{8} \cdot\left(d_{2}^{2}+2 \varepsilon_{2}\right)^{2} n^{6} \cdot\left(d_{2}^{4}+4 \varepsilon_{2}\right) n^{4} \cdot \delta_{3} d_{2}^{12} n^{6} \stackrel{(4)}{\leqslant} 2 \delta_{3} d_{2}^{24} n^{24}
$$

which concludes the proof of Proposition 1.4.

## §3. Proof of Theorem 1.5: Regularity implies Conformity

Theorem 1.5 is a consequence of Theorem 3.1 below, which extends (2) to regular complexes $\mathcal{H}=((X, Y, Z), G, H)$. In particular, Theorem 3.1 asserts that $\mathcal{H}$ admits around the expected number of labeled induced copies of any spanning subhypergraph $F$ of the octahedron $K_{2,2,2}^{(3)}$ :

$$
V\left(K_{2,2,2}^{(3)}\right)=\left\{x_{0}, x_{1}\right\} \cup\left\{y_{0}, y_{1}\right\} \cup\left\{z_{0}, z_{1}\right\} \quad \text { and } \quad E\left(K_{2,2,2}^{(3)}\right)=\left\{x_{\lambda} y_{\mu} z_{\nu}: \lambda, \mu, \nu \in\{0,1\}\right\} .
$$

For this, a map $\varphi: V(F) \longrightarrow V(G)$ is a partite homomorphism of $F$ into $\mathcal{H}$ when
(1) $\varphi\left(x_{0}\right), \varphi\left(x_{1}\right) \in X, \varphi\left(y_{0}\right), \varphi\left(y_{1}\right) \in Y$, and $\varphi\left(z_{0}\right), \varphi\left(z_{1}\right) \in Z$;
(2) $\varphi\left(x_{\lambda}\right) \varphi\left(y_{\mu}\right) \varphi\left(z_{\nu}\right) \in \mathcal{K}_{3}(G)$ for all $\lambda, \mu, \nu \in\{0,1\}$;
(3) $\varphi\left(x_{\lambda}\right) \varphi\left(y_{\mu}\right) \varphi\left(z_{\nu}\right) \in E(H)$ whenever $x_{\lambda} y_{\mu} z_{\nu} \in E(F)$.

When, additionally, $\varphi$ satisfies
$\left(3^{\prime}\right) \varphi\left(x_{\lambda}\right) \varphi\left(y_{\mu}\right) \varphi\left(z_{\nu}\right) \in E(H)$ if, and only if, $x_{\lambda} y_{\mu} z_{\nu} \in E(F)$,
we say that $\varphi$ is a partite induced homomophism of $F$ into $\mathcal{H}$. In these contexts, we denote by $\operatorname{hom}(F, \mathcal{H})(\operatorname{ihom}(F, \mathcal{H}))$ the number of partite (induced) homomorphisms of $F$ into $\mathcal{H}$.

Theorem 3.1. For all $\eta>0$ and $d_{3} \in[0,1]$, there exists $\varepsilon_{3}>0$ so that for every $d_{2}>0$, there exist $\varepsilon_{2}>0$ and $n_{0} \geqslant 1$ so that the following holds for every spanning subhypergraph $F$ of $K_{2,2,2}^{(3)}$. If $\mathcal{H}$ is an $\left(\varepsilon_{3}, d_{3}\right)$-regular $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n \geqslant 3 n_{0}$ many vertices, then

$$
\begin{equation*}
\left|\operatorname{ihom}(F, \mathcal{H})-d_{3}^{|E(F)|}\left(1-d_{3}\right)^{8-|E(F)|} d_{2}^{12} n^{6}\right| \leqslant \eta \cdot d_{2}^{12} n^{6} . \tag{6}
\end{equation*}
$$

We defer the proof of Theorem 3.1 to Section 5.
Proof of Theorem 1.5. For any given $\delta_{3}, d_{3}>0$ we set $\eta=\delta_{3} / 256$ and for $d_{2}>0$, let $\mathcal{H}=((X, Y, Z), G, H)$ be an $\left(\varepsilon_{3}, d_{3}\right)$-regular $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n \geqslant 3 n_{0}$ vertices, where $\varepsilon_{3}=\varepsilon_{3}\left(\delta_{3}, d_{3}, \eta\right)>0, \varepsilon_{2}=\varepsilon_{2}\left(\delta_{3}, d_{3}, \eta, d_{2}\right)>0$, and $n_{0}=n_{0}\left(\delta_{3}, d_{3}, \eta, d_{2}, \varepsilon_{2}\right) \in \mathbb{N}$ are those parameters guaranteed by Theorem 3.1. It follows from (3) that

$$
\sum_{x_{0}, x_{1} \in X} \sum_{y_{0}, y_{1} \in Y} \sum_{z_{0}, z_{1} \in Z} \prod_{\lambda, \mu, \nu \in\{0,1\}} f_{\mathcal{H}, d_{3}}\left(x_{\lambda}, y_{\mu}, z_{\nu}\right)=\sum_{F}\left(1-d_{3}\right)^{|E(F)|}\left(-d_{3}\right)^{8-|E(F)|} \cdot \operatorname{ihom}(F, \mathcal{H}),
$$

where the sum on the right-hand side runs over all 256 labeled spanning subhypergraphs of $K_{2,2,2}^{(3)}$. Applying Theorem 3.1 to all such $F$ bounds the left-hand side from above by

$$
256 \eta d_{2}^{12} n^{6}+\sum_{F}(-1)^{8-|E(F)|} \cdot d_{3}^{8}\left(1-d_{3}\right)^{8} d_{2}^{12} n^{6}=256 \eta d_{2}^{12} n^{6}
$$

and the $\left(\delta_{3}, d_{3}\right)$-conformity of $\mathcal{H}$ follows from the choice of $\eta$.

## §4. Regularity Method for 3-uniform Hypergraphs

In this section, we state a regularity lemma from [3] (Theorem 4.2 below) and a counting lemma from [8] (Theorem 4.4 below) which we need for proving Theorem 3.1. These require the following notion of a regular complex, which is somewhat stronger than Definition 1.2.

Definition 4.1 ( $r$-regular complex). Let $\mathcal{H}=((X, Y, Z), G, H)$ be an $\left(\varepsilon_{2}, d_{2}\right)$-complex. For $\varepsilon_{3}>0, d_{3} \in[0,1]$, and an integer $r \geqslant 1$, we say $\mathcal{H}$ is $\left(\varepsilon_{3}, d_{3}, r\right)$-regular if all sequences $\boldsymbol{J}=\left(J_{1}, \ldots, J_{r}\right)$ of subgraphs of $G$ satisfy

$$
\left|e_{H}(\boldsymbol{J})-d_{3}\right| \mathcal{K}_{3}(\boldsymbol{J})| | \leqslant \varepsilon_{3}\left|\mathcal{K}_{3}(G)\right|,
$$

where $e_{H}(\boldsymbol{J})=\left|\bigcup_{i=1}^{r} E_{H}\left(J_{i}\right)\right|$ and $\mathcal{K}_{3}(\boldsymbol{J})=\bigcup_{i=1}^{r} \mathcal{K}_{3}\left(J_{i}\right)$. Moreover, we say $\mathcal{H}$ is $\left(\varepsilon_{3}, r\right)$-regular when it is $\left(\varepsilon_{3}, d_{3}, r\right)$-regular for $d_{3}=d(H \mid G)$.

We remark that for $r=1$, Definition 4.1 reduces to Definition 1.2. Otherwise, Definition 4.1 is stronger than Definition 1.2, and for large $r$ it is stronger than Definition 1.3 (see [2]).

The following regularity lemma for complexes is adapted from [3] (see, e.g., [11, Lemma 4.1]).
Theorem 4.2 (Regularity Lemma). For all constants $d_{2}, \xi_{3}>0$, integers $\ell_{0}, t_{0} \geqslant 1$, and functions $\xi_{2}:(0,1] \longrightarrow(0,1]$ and $r:(0,1] \times \mathbb{N} \longrightarrow \mathbb{N}$, there exist a constant $\varepsilon_{2}>0$ and integers $L_{0}, T_{0}$, and $N_{0}$ so that the following hold.

Let $\mathcal{H}=((X, Y, Z), G, H)$ be an $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n \geqslant 3 N_{0}$ vertices, where $T_{0}$ ! divides $n$. There exist integers $\ell$ and $t$ with $\ell_{0} \leqslant \ell \leqslant L_{0}, t_{0} \leqslant t \leqslant T_{0}$, vertex partitions $\bigcup_{i \in[t]} X_{i}=X$, $\bigcup_{j \in[t]} Y_{j}=Y$, and $\bigcup_{k \in[t]} Z_{k}=Z$, edge-partitions

$$
\bigcup_{i, j \in[t]} \bigcup_{\alpha \in[\ell]} P_{\alpha}^{i j}=E(G[X, Y]), \bigcup_{i, k \in[t]} \bigcup_{\beta \in[\ell]} Q_{\beta}^{i k}=E(G[X, Z]) \text {, and } \bigcup_{j, k \in[t]} \bigcup_{\gamma \in[\ell]} R_{\gamma}^{j k}=E(G[Y, Z]) \text {, }
$$

and complexes $\mathcal{H}_{\alpha \beta \gamma}^{i j k}=\left(\left(X_{i}, Y_{j}, Z_{k}\right), G_{\alpha \beta \gamma}^{i j k}, H_{\alpha \beta \gamma}^{i j k}\right)$ for every $(i, j, k, \alpha, \beta, \gamma) \in[t]^{3} \times[\ell]^{3}$, where

$$
G_{\alpha \beta \gamma}^{i j k}=\left(X_{i} \cup Y_{j} \cup Z_{k}, P_{\alpha}^{i j} \cup Q_{\beta}^{i k} \cup R_{\gamma}^{j k}\right) \quad \text { and } \quad H_{\alpha \beta \gamma}^{i j k}=\left(X_{i} \cup Y_{j} \cup Z_{k}, E(H) \cap \mathcal{K}_{3}\left(G_{\alpha \beta \gamma}^{i j k}\right)\right),
$$

satisfying the following properties:
(a) all $\mathcal{H}_{\alpha \beta \gamma}^{i j k}$ above are $\left(\xi_{2}\left(d_{2} / \ell\right), d_{2} / \ell\right)$-complexes on $3 n / t$ vertices;
(b) all but $\xi_{3} t^{3} \ell^{3}$ many $\mathcal{H}_{\alpha \beta \gamma}^{i j k}$ above are $\left(\xi_{3}, r\left(d_{2} / \ell, t\right)\right)$-regular.

We call the graphs $G_{\alpha \beta \gamma}^{i j k}$ of Theorem 4.2 the triads of the regular partition.
In Theorem 4.4 below, we consider a special case of the counting lemma from [8], tailored for counting subhypergraphs of the octahedron $K_{2,2,2}^{(3)}$ within the following octahedral complexes.

Definition 4.3 (octahedral complex). For $\xi_{2}>0$ and $d>0$, an octahedral ( $\left.\xi_{2}, d\right)$-complex $\mathcal{O}=\left(\left(X_{0}, X_{1}, Y_{0}, Y_{1}, Z_{0}, Z_{1}\right), G, H\right)$ is a triple satisfying the following properties:
(i) $X_{0}, X_{1}, Y_{0}, Y_{1}, Z_{0}$, and $Z_{1}$ are pairwise disjoint vertex sets of common size;
(ii) $G$ is a 3-partite graph with vertex classes $X_{0} \cup X_{1}, Y_{0} \cup Y_{1}$, and $Z_{0} \cup Z_{1}$, and $H$ is a 3 -partite 3 -uniform hypergraph which $G$ underlies;
(iii) for each $\lambda, \mu, \nu \in\{0,1\}$, the complex

$$
\mathcal{O}^{\lambda \mu \nu}=\left(\left(X_{\lambda}, Y_{\mu}, Z_{\nu}\right), G^{\lambda \mu \nu}=G\left[X_{\lambda}, Y_{\mu}, Z_{\nu}\right], H^{\lambda \mu \nu}\right),
$$

where $E\left(H^{\lambda \mu \nu}\right)=E(H) \cap \mathcal{K}_{3}\left(G^{\lambda \mu \nu}\right)$, is a $\left(\xi_{2}, d\right)$-complex.
Moreover, for $\xi_{3}>0$ and an integer $r \geqslant 1$, we say $\mathcal{O}$ is $\left(\xi_{3}, r\right)$-regular when all $\lambda, \mu, \nu \in\{0,1\}$ satisfy that $\mathcal{O}^{\lambda \mu \nu}$ is $\left(\xi_{3}, r\right)$-regular.

Fix a spanning subhypergraph $F$ of the octahedron $K_{2,2,2}^{(3)}$ on the fixed vertex partition

$$
V(F)=\left\{x_{0}, x_{1}\right\} \cup\left\{y_{0}, y_{1}\right\} \cup\left\{z_{0}, z_{1}\right\}
$$

and fix an octahedral complex $\mathcal{O}=\left(\left(X_{0}, X_{1}, Y_{0}, Y_{1}, Z_{0}, Z_{1}\right), G, H\right)$. A map $\varphi: V(F) \longrightarrow V(G)$ is a partite homomorphism of $F$ into $\mathcal{O}$ when all $\lambda, \mu, \nu \in\{0,1\}$ satisfy the following properties:
(1) $\varphi\left(x_{\lambda}\right) \in X_{\lambda}, \varphi\left(y_{\mu}\right) \in Y_{\mu}$, and $\varphi\left(z_{\nu}\right) \in Z_{\nu}$;
(2) $\varphi\left(x_{\lambda}\right) \varphi\left(y_{\mu}\right) \varphi\left(z_{\nu}\right) \in \mathcal{K}_{3}(G)$;
(3) $\varphi\left(x_{\lambda}\right) \varphi\left(y_{\mu}\right) \varphi\left(z_{\nu}\right) \in E(H)$ whenever $x_{\lambda} y_{\mu} z_{\nu} \in E(F)$.

We denote by $\operatorname{hom}(F, \mathcal{O})$ the number of partite homomorphisms of $F$ into $\mathcal{O}$.
Theorem 4.4 (Octahedral Counting Lemma). For every $\vartheta>0$, there exist $\xi_{3}>0$ and functions $\xi_{2}:(0,1] \longrightarrow(0,1], r:(0,1] \longrightarrow \mathbb{N}$, and $m_{0}:(0,1] \longrightarrow \mathbb{N}$ such that for all $d \in(0,1]$, the following holds. For every $\left(\xi_{3}, r(d)\right)$-regular octahedral $\left(\xi_{2}(d), d\right)$-complex $\mathcal{O}=\left(\left(X_{0}, X_{1}, Y_{0}, Y_{1}, Z_{0}, Z_{1}\right), G, H\right)$ on $3 m \geqslant 3 m_{0}(d)$ vertices, and for and every spanning subhypergraph $F$ of $K_{2,2,2}^{(3)}$, we have

$$
\left|\operatorname{hom}(F, \mathcal{O})-d^{12} m^{6} \prod_{x_{\lambda} y_{\mu} z_{\nu} \in E(F)} d\left(H \mid G^{\lambda \mu \nu}\right)\right| \leqslant \vartheta d^{12} m^{6} .
$$

The essential difference between Theorems 3.1 and 4.4 (aside from counting induced versus non-induced homomorphisms) is the assumed regularity of the given complex. In Theorem 3.1, the given complex $\mathcal{H}$ is $\left(\varepsilon_{3}, d_{3}\right)$-regular, while in Theorem 4.4, the given octahedral complex $\mathcal{O}$ satisfies the stronger property of being $\left(\xi_{3}, r\right)$-regular for some large integer $r$ depending on the density of the underlying graph $G$.

## §5. Proof of Theorem 3.1

In this section, we prove Theorem 3.1 in a non-induced but equivalent form.
Theorem 5.1. For all $\eta>0$ and $d_{3} \in[0,1]$, there exists $\varepsilon_{3}>0$ so that for every $d_{2}>0$, there exist $\varepsilon_{2}>0$ and $n_{0} \geqslant 1$ so that the following holds for every spanning subhypergraph $F$ of $K_{2,2,2}^{(3)}$. If $\mathcal{H}$ is an $\left(\varepsilon_{3}, d_{3}\right)$-regular $\left(\varepsilon_{2}, d_{2}\right)$-complex on $3 n \geqslant 3 n_{0}$ many vertices, then

$$
\left|\operatorname{hom}(F, \mathcal{H})-d_{3}^{|E(F)|} d_{2}^{12} n^{6}\right| \leqslant \eta \cdot d_{2}^{12} n^{6} .
$$

Up to the error $\eta$, Theorems 3.1 and Theorems 5.1 are equivalent. Indeed, fixing $F$ above,

$$
\operatorname{hom}(F, \mathcal{H})=\sum_{F^{\prime}} \operatorname{ihom}\left(F^{\prime}, \mathcal{H}\right) \quad \text { and } \quad \operatorname{ihom}(F, \mathcal{H})=\sum_{F^{\prime}}(-1)^{\left|E\left(F^{\prime}\right)\right|-|E(F)|} \operatorname{hom}\left(F^{\prime}, \mathcal{H}\right)
$$

where we sum over all spanning subhypergraphs $F^{\prime}$ satisfying $F \subseteq F^{\prime} \subseteq K_{2,2,2}^{(3)}$, and where we use the elementary identities
$d_{3}^{|E(F)|}=\sum_{F^{\prime}} d_{3}^{\left|E\left(F^{\prime}\right)\right|}\left(1-d_{3}\right)^{8-\left|E\left(F^{\prime}\right)\right|} \quad$ and $\quad d_{3}^{|E(F)|}\left(1-d_{3}\right)^{8-|E(F)|}=\sum_{F^{\prime}}(-1)^{\left|E\left(F^{\prime}\right)\right|-|E(F)|} d_{3}^{\left|E\left(F^{\prime}\right)\right|}$.
In the proof of Theorem 5.1, we invoke the regularity method from Section 4. We also use the following standard consequence of the counting lemma for graphs.

Fact 5.2 (counting/extension lemma for graphs). For all tripartite graphs $G=\left(X \cup Y \cup Z, E_{G}\right)$ with $G[X, Y], G[X, Z]$, and $G[Y, Z]$ being $(\varepsilon, d)$-regular we have
(a) $\left|\left|\mathcal{K}_{3}(G)\right|-d^{3}\right| X||Y|| Z||\leqslant 3 \varepsilon| X||Y||Z|$
(b) and all but $4 \varepsilon^{1 / 4}|X||Y||Z|$ many triangles of $G$ extend to at most $\left(d^{9}+4 \varepsilon^{1 / 4}\right)|X||Y||Z|$ partite homomorphisms of $K_{2,2,2}$ into $G$.
Similarly, given a tripartite graph $G=\left(X \cup Y \cup Z, E_{G}\right)$ with vertex classes $X=X_{0} \cup X_{1}$, $Y=Y_{0} \cup Y_{1}$, and $Z=Z_{0} \cup Z_{1}$ with $G\left[X_{\lambda}, Y_{\mu}\right], G\left[X_{\lambda}, Z_{\nu}\right]$, and $G\left[Y_{\mu}, Z_{\nu}\right]$ being $(\varepsilon, d)$-regular for all $\lambda, \mu, \nu \in\{0,1\}$ we have
(c) $\left|\operatorname{hom}\left(K_{2,2,2}, G\right)-d^{12}\right| X_{0}| | X_{1}| | Y_{0}| | Y_{1}| | Z_{0}| | Z_{1}| | \leqslant 12 \varepsilon\left|X_{0}\left\|X_{1}| | Y_{0}| | Y_{1}\right\| Z_{0} \| Z_{1}\right|$, where in $\operatorname{hom}\left(K_{2,2,2}, G\right)$ we only consider those homomorphisms $\varphi$ from $V\left(K_{2,2,2}\right)=\left\{x_{0}, x_{1}\right\} \cup$ $\left\{y_{0}, y_{1}\right\} \cup\left\{z_{0}, z_{1}\right\}$ such that $\varphi\left(x_{0}\right) \in X_{0}, \ldots, \varphi\left(z_{1}\right) \in Z_{1}$.

Note that Fact $5.2(c)$ also applies in a situation when for example $X_{0}$ and $X_{1}$ are not disjoint.
Proof of Theorem 5.1. We start by defining all involved constants. Following the quantification of the theorem for given $\eta>0$ and $d_{3} \in[0,1]$ we define

$$
\begin{equation*}
\varepsilon_{3}=\frac{\eta}{2^{13}} . \tag{7}
\end{equation*}
$$

Let $d_{2}>0$ be given. To define the corresponding constant $\varepsilon_{2}>0$, we assemble constants and functions suitable for applications of Theorems 4.2 and 4.4. To that end, set

$$
\begin{equation*}
\vartheta=\frac{\eta}{2^{12}} . \tag{8}
\end{equation*}
$$

Let $\xi_{3}>0$ and functions $\xi_{2}:(0,1] \longrightarrow(0,1], r:(0,1] \longrightarrow \mathbb{N}$ and $m_{0}:(0,1] \longrightarrow \mathbb{N}$ be those parameters guaranteed by Theorem 4.4. W.l.o.g., we may assume that

$$
\begin{equation*}
\xi_{3} \leqslant \frac{\eta}{2^{15}} \stackrel{(7)}{=} \frac{\varepsilon_{3}}{4}, \quad \text { and } \quad \xi_{2}(\zeta) \leqslant \frac{\eta}{3 \cdot 2^{12}} \zeta^{12} \quad \text { for all } \zeta \in(0,1] \tag{9}
\end{equation*}
$$

and that $m_{0}(x)$ decreases in $x$. With constants $d_{2}, \xi_{3}>0$ fixed above, with fixed integers

$$
\begin{equation*}
t_{0}=\left\lceil\frac{2^{12}}{\eta}\right\rceil \tag{10}
\end{equation*}
$$

and $\ell_{0}=1$, and with functions $\xi_{2}(\cdot)$ and $r(\cdot)$ fixed above, Theorem 4.2 guarantees a constant $\varepsilon_{2}^{\prime}>0$ and positive integers $L_{0}, T_{0}$, and $N_{0}$. We define the promised constant

$$
\begin{equation*}
\varepsilon_{2}=\min \left\{\varepsilon_{2}^{\prime},\left(\frac{\eta d_{2}^{12}}{12 \cdot 2^{10}}\right)^{4}, \frac{d_{2}^{12}}{12 T_{0}}\right\}, \tag{11}
\end{equation*}
$$

and we take the integer $n_{0}$ to be sufficiently large whenever needed.
Let $\mathcal{H}=((X, Y, Z), G, H)$ be an $\left(\varepsilon_{3}, d_{3}\right)$-regular $\left(\varepsilon_{2}, d_{2}\right)$-complex with $|X|=|Y|=|Z|=$ $n \geqslant n_{0}$, where $\varepsilon_{3}, \varepsilon_{2}$, and $n_{0}$ are defined above. It suffices to assume that $T_{0}$ ! divides $n$ since removing up to $T_{0}$ ! vertices from each of $X, Y$, and $Z$ decreases $\operatorname{hom}(F, \mathcal{H})$ by only $6 T_{0}!n^{5}=O\left(n^{5}\right)$ while still resulting in a $\left(2 \varepsilon_{3}, d_{3}\right)$-regular $\left(2 \varepsilon_{2}, d_{2}\right)$-complex.

For every fixed spanning subhypergraph $F \subseteq K_{2,2,2}^{(3)}$ we shall establish

$$
\begin{equation*}
\left|\operatorname{hom}(F, \mathcal{H})-d_{3}^{|E(F)|} d_{2}^{12} n^{6}\right| \leqslant \frac{2^{|E(F)|}}{2^{8}} \eta \cdot d_{2}^{12} n^{6} . \tag{12}
\end{equation*}
$$

Note that (12) holds when $F$ is the empty (spanning) subhypergraph of $K_{2,2,2}^{(3)}$, since then $\operatorname{hom}(F, \mathcal{H})=\operatorname{hom}\left(K_{2,2,2}, G\right)$, for which $(c)$ of Fact 5.2 yields

$$
\left|\operatorname{hom}(F, \mathcal{H})-d_{3}^{0} \cdot d_{2}^{12} n^{6}\right| \leqslant 12 \varepsilon_{2} n^{6} \stackrel{(11)}{\leqslant} \frac{2^{0}}{2^{8}} \eta \cdot d_{2}^{12} n^{6}
$$

We assume, for a contradiction, that there exists an edge-minimal non-empty spanning subhypergraph $F$ of $K_{2,2,2}^{(3)}$ for which (12) fails. W.l.o.g., we assume that $x_{0} y_{0} z_{0} \in E(F)$ and we set $F^{-}=F-x_{0} y_{0} z_{0}$ to be the subhypergraph of $F$ obtained by removing the hyperedge $x_{0} y_{0} z_{0}$. Since (12) fails for $F$ but holds for $F^{-}$, we deduce that

$$
\begin{equation*}
\left|\operatorname{hom}(F, \mathcal{H})-d_{3} \cdot \operatorname{hom}\left(F^{-}, \mathcal{H}\right)\right|>\frac{2^{|E(F)|}-d_{3} \cdot 2^{\left|E\left(F^{-}\right)\right|}}{2^{8}} \eta \cdot d_{2}^{12} n^{6} \geqslant \frac{\eta}{2^{8}} \cdot d_{2}^{12} n^{6} \tag{13}
\end{equation*}
$$

We shall use the discrepancy in (13) to establish the existence of a subgraph $J_{0} \subseteq G$ violating the regularity of $\mathcal{H}$ :

$$
\begin{equation*}
\left|e_{H}\left(J_{0}\right)-d_{3}\right| \mathcal{K}_{3}\left(J_{0}\right)| |>\varepsilon_{3} \cdot d_{2}^{3} n^{3} . \tag{14}
\end{equation*}
$$

The proof of the existence of $J_{0}$ consist of four steps. First, we apply Theorem 4.2 and locate a triad in the regular partition where (13) carries over (in an appropriately scaled way) to copies of $F^{-}$and $F$ that extend hyperedges supported by that triad (see (18) below).

Step 1: Applying the regularity lemma. We apply Theorem 4.2 to $\mathcal{H}$ with the chosen parameters $d_{2}, \xi_{3}, \ell_{0}, t_{0}, \xi_{2}(\cdot)$ and $r(\cdot)$. Theorem 4.2 guarantees integers $\ell_{0} \leqslant \ell \leqslant L_{0}$ and $t_{0} \leqslant t \leqslant T_{0}$, vertex partitions $\bigcup_{i \in[t]} X_{i}=X, \bigcup_{j \in[t]} Y_{j}=Y$, and $\bigcup_{k \in[t]} Z_{k}=Z$, edge-partitions
$\bigcup_{i, j \in[t]} \bigcup_{\alpha \in[\ell]} P_{\alpha}^{i j}=E(G[X, Y]), \bigcup_{i, k \in[t]} \bigcup_{\beta \in[\ell]} Q_{\beta}^{i k}=E(G[X, Z])$, and $\bigcup_{j, k \in[t]} \bigcup_{\gamma \in[\ell]} R_{\gamma}^{j k}=E(G[Y, Z])$,
and complexes $\mathcal{H}_{\alpha \beta \gamma}^{i j k},(i, j, k, \alpha, \beta, \gamma) \in[t]^{3} \times[\ell]^{3}$, where

$$
G_{\alpha \beta \gamma}^{i j k}=\left(X_{i} \cup Y_{j} \cup Z_{k}, P_{\alpha}^{i j} \cup Q_{\beta}^{i k} \cup R_{\gamma}^{j k}\right) \quad \text { and } \quad H_{\alpha \beta \gamma}^{i j k}=\left(X_{i} \cup Y_{j} \cup Z_{k}, E(H) \cap \mathcal{K}_{3}\left(G_{\alpha \beta \gamma}^{i j k}\right)\right),
$$

which satisfy properties $(a)$ and $(b)$ of its conclusion. We set

$$
m=\frac{n}{t}, \quad \xi_{2}=\xi_{2}\left(\frac{d_{2}}{\ell}\right), \quad \text { and } \quad r=r\left(\frac{d_{2}}{\ell}\right)
$$

and note that $m \geqslant n / T_{0} \geqslant m_{0}\left(d_{2} / \ell\right)$ and by (9) we have

$$
\begin{equation*}

We remove hyperedges $x y z$ from $H$ when they belong to some $H_{\alpha \beta \gamma}^{i j k}$ for which $\mathcal{H}_{\alpha \beta \gamma}^{i j k}$ is not $\left(\xi_{3}, r\right)$-regular, and we let $H^{\prime}$ and $\mathcal{H}^{\prime}$ denote the resulting hypergraph and complex. By $(b)$ of Theorem 4.2 and ( $a$ ) of Fact 5.2,

\end{aligned}

Thus, inequality (13) can be transferred from $\mathcal{H}$ to $\mathcal{H}^{\prime}$ by

Next we shall find a triad $G_{\alpha \beta \gamma}^{i j k}$ such that a similar (appropriately scaled) inequality like (17) holds for the homomorphisms of $F$ and $F^{-}$in $H^{\prime}$ that map the three vertices $x_{1}, y_{1}, z_{1}$ to $\mathcal{K}_{3}\left(G_{\alpha \beta \gamma}^{i j k}\right)$ and the other three vertices $x_{0}, y_{0}, z_{0}$ (which span the additional hyperedge in $F$ ) outside $X_{i}, Y_{k}$, and $Z_{k}$. For that we denote by $\operatorname{hom}\left(F, H^{\prime} \mid G_{\alpha \beta \gamma}^{i j k}\right)$ (respectively by $\left.\operatorname{hom}\left(F^{-}, H^{\prime} \mid G_{\alpha \beta \gamma}^{i j k}\right)\right)$ the number of those injective partite homomorphisms. It follows from (c) of Fact 5.2 that are at most

Consequently, summing hom $\left(F, H^{\prime} \mid G_{\alpha \beta \gamma}^{i j k}\right)$ over all $t^{3} \ell^{3}$ triads $G_{\alpha \beta \gamma}^{i j k}$ of the regular partition yields

Step 2: Further restricting the considered copies of $F^{-}$and $F$. In the second step, we further restrict the set of copies of $F$ and $F^{-}$that we consider in (18). For that, fix $1 \leqslant i \leqslant t-1$. We wish to select a fixed bipartite graph $P_{\alpha_{i}}^{i t}$ among the $\ell$ such with vertex bipartition $X_{i} \cup Y_{t}$. More generally, for all $i, j, k \in[t-1]$ we wish to respectively select

we denote by $\operatorname{hom}\left(F, \mathcal{H}^{\prime} \mid G_{\ell \ell \ell}^{t t t}, \vec{a}\right)$ (respectively $\operatorname{hom}\left(F^{-}, \mathcal{H}^{\prime} \mid G_{\ell \ell \ell}^{t t t}, \vec{a}\right)$ ) the number of partite homomorphisms $\varphi$ from $F$ (resp. $F^{-}$) to $\mathcal{H}^{\prime}$ that satisfy

Homomorphisms $\varphi$ satisfying (19) alone are counted by $\operatorname{hom}\left(F, \mathcal{H}^{\prime} \mid G_{\ell \ell \ell}^{t t t}\right)$, and for each such there are precisely $\ell^{6(t-2)}$ vectors $\vec{a} \in[\ell]^{6(t-1)}$ so that $\varphi$ also satisfies (20). Consequently,

In Step 1, we fixed the triad $G_{\ell \ell \ell}^{t t t}$ to satisfy (18), and in Step 2, we fixed the vector $\vec{a}$ to satisfy (21). We now observe that every triad $G_{\alpha \beta \gamma}^{i j k}$ with $i, j, k \in[t-1]$ determines a unique octahedral complex (see Definition 4.3)

In Step 3, we will invoke Theorem 4.4 to evaluate the differences above.
Step 3: Applying the octahedral counting lemma. Theorem 4.4 expresses each $\operatorname{hom}\left(F, \mathcal{O}_{\alpha \beta \gamma}^{i j k}\right)$ and $\operatorname{hom}\left(F^{-}, \mathcal{O}_{\alpha \beta \gamma}^{i j k}\right)$ in (23) as products of densities of triads of $\mathcal{O}_{\alpha \beta \gamma}^{i j k}$. We express these same densities in terms of the following piece-wise defined weight function $w: V(G) \cup E(G) \longrightarrow[0,1]$. First, we weight all vertices $v \in V(G)$ and edges $e \in E(G)$ incident to $X_{t} \cup Y_{t} \cup Z_{t}$ with $w(v)=w(e)=1$. Then, we weight remaining vertices and edges of $G$ systematically by the
following constant functions: for each $(i, j, k, \alpha, \beta, \gamma) \in[t-1]^{3} \times[\ell]^{3}$, set

\left.w\right|_{P_{\alpha}^{i j}} & \equiv \begin{cases}d\left(H^{\prime} \mid G_{\alpha 11}^{i j t}\right) & \text { if } x_{0} y_{0} z_{1} \in E(F), \\

Finally, we define the weight of the triad $G_{\alpha \beta \gamma}^{i j k}$ by the product of the six values given to its vertex classes and edge sets, i.e., we set

Similarly, for $F^{-}$we arrive at

It follows that $w_{111}>0$ and, since by definition $w_{111} \leqslant 1$, we may divide both sides by $w_{111}$ and, owing to another application of $(a)$ of Fact 5.2 for every triad $G_{\alpha \beta \gamma}^{i j k}$ considered in the sum, we can replace $\left(d_{2} / \ell\right)^{3} m^{3}$ by $\left|\mathcal{K}_{3}\left(G_{\alpha \beta \gamma}^{i j k}\right)\right| \pm 3 \xi_{2} m^{3}$. Rewriting the left-hand side by summing over all triangles of $G^{\prime}=G\left[X \backslash X_{t}, Y \backslash Y_{t}, Z \backslash Z_{t}\right]$ instead over all triads $G_{\alpha \beta \gamma}^{i j k} \subseteq G^{\prime}$ and expanding $w\left(G_{\alpha \beta \gamma}^{i j k}\right)$ according to (24) tells us

Step 4: Determining the promised subgraph $J_{0} \subseteq G$. Inequality (25) shows that there exists a weighted subgraph of $G^{\prime}$ such that the weighted version of Definition 1.2 fails. Since all weights are in $[0,1]$, we may view them as a probability distribution over all subgraph of $J \subseteq G^{\prime}$ and the left-hand side of (25) corresponds the expected value of $\left|e_{H^{\prime}}(J)-d_{3}\right| \mathcal{K}_{3}(J)| |$. Consequently, there exists a concrete subgraph $J \subseteq G^{\prime} \subseteq G$ such that

$$
\left|e_{H^{\prime}}(J)-d_{3}\right| \mathcal{K}_{3}(J)| |>2 \varepsilon_{3} \cdot d_{2}^{3} n^{3} .
$$

Finally, (16) allows us to move back from $H^{\prime}$ to $H$ and we get the desired inequality

$$
\left|e_{H}(J)-d_{3}\right| \mathcal{K}_{3}(J)| | \geqslant\left|e_{H^{\prime}}(J)-d_{3}\right| \mathcal{K}_{3}(J)| |-2 \xi_{3} d_{2}^{3} n^{3} \stackrel{(9)}{>} \varepsilon_{3} \cdot d_{2}^{3} n^{3},
$$

which yields the desired contradiction to the $\left(\varepsilon_{3}, d_{3}\right)$-regularity of the $\left(\varepsilon_{2}, d_{2}\right)$-complex $\mathcal{H}$ and concludes the proof of Theorem 3.1.
